There are at least three outdoor pens that have large holes where the dogs have dug. Some of the holes are large enough that could cause injury to the dogs. The licensee needs to fill the holes so the dogs do not injury themselves.

Item No: 10 General Requirements for Structure and Construction

2 CSR 30-9.030 (1) (A) 1. Housing facilities for dogs and cats must protect the animals from injury, contain the animals securely and restrict other animals from entering.

There is one outdoor enclosure that has two large holes approximately 12" in diameter and 5 " deep. These holes pose a risk of injury to the dogs. The licensee needs to fill the holes to prevent a risk of injury.

2 CSR 30-9.030 (1) (A) 3. C. All other (non-floor) surfaces of housing facilities must be cleaned and sanitized when necessary to satisfy generally accepted husbandry standards and practices.

The whelping building contains an accumulation of hair, dirt and grime on the pens and pvc pipe that run along the enclosures. In addition, there were two enclosures in the building that contained food and water but there were no dogs occupying the pens. The licensee shall provide a deep cleaning to the whelping building removing the dirt, hair and grime. In addition, when dogs are removed from the enclosures the licensee shall clean the pen.

2 CSR 30-9.030 (1) (A) 3. B. Maintenance and replacement of surfaces. All surfaces must be maintained on a regular basis. Surfaces of housing facilities, including houses, dens and other furniture-type fixtures and objects within the facility, that cannot be readily cleaned and sanitized, must be replaced when worn or soiled.

Some of the whelping pans are chewed and cracked and can no longer be properly cleaned and sanitized. The licensee shall replace the chewed and cracked pans to satisfy animal husbandry standards.

2 CSR 30-9.030 (1) (D) 3. Building surfaces in contact with animals in outdoor housing facilities must be impervious to moisture.

There are several outdoor hutches where the paint is wearing off and portions of the hutches are no longer impervious to moisture. The licensee shall paint and/or seal all the ourdoor hutches so they will be impervious to moisture and increase their longevity.

There is a female American Bulldog (no identification) that had hair loss on the top of her head. The licensee has been self medicating the dog with "Blue Lotion" for a day but during the inspection it was noted that were several flies on top of the area. The licensee shall consult with their attending veterinarian for appropriate treament and a record should be maintained and presented at the next inspection.
